#### III. GENERAL TERMS OF AGREEMENT

### 1. Confidentiality:

5. Manpower & Manpower Training:

Trainer and other manpower will be from Cyber Web only.

The relationship here by established between the parties is soli that of independent contractor this agreement cell not be interpreted as the creation of an agency partnership joint venture or employer employee relationship.

6. Modification of agreement in modification of this agreement or additional obligation assumed about this agreement shall be binding only if partner provide communication with regard to such changes to Cyber Web.
