- 3. Income Tax return Acknowledgment should be submitted for the Last 3 years (AY 25-26, AY 24-25, AY 23-24) Scan copy.

Terms & Condition:

- 1. Credential: Applicant must have experience of executing at least one single work of similar nature of work amounting not less than 40% of the bid value Only for the above-mentioned supply within last 3 (Three) years. The said credentials must be from any Govt./Semi Govt. /Private organization. OEM authorization of CCTV is a mandatory requirement.
- 1. Authority reserves right to accept or reject unilaterally without assigning any reason. The decision of the authority will be Final and Binding.
- 2. The work should be executed on the basis of specification contained in the tender papers and guidelines issued time to time.
- 3. Proper legal action will be taken along with black listing against tenderers who will submit incorrect/ fake certificate with tender.
- 4. No escalation in the rate will be allowed and no claim on delayed payment due to unavoidable reasons will be entertained.
- 5. Tenderers should participate after inspection of work site.
- 6. Conditional tender will not be entertained
- 7. Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.

General Conditions of Tender:

- 1. Rate should be quoted in Item wise figure basis.
- 2. Each Bidder shall submit only one Bid for one work. A Bidder who submits more than one Bid for one particular bid will cause the proposals with the Bidder's participation to be disqualified
- 3. No payment will be made for materials not conforming to specifications.
- 4. No extra payment will be made out of Tender rate or for carriage by Head load, even though it was necessary
- 5. The earnest money deposited will be released to the unsuccessful tenderers after expiry 10 (ten) days from the date of opening the Tender
- 6. The successful tenderer shall have to execute an agreement with the Principal, Ghatal Rabindra Satabarsiki Mahavidyalaya on a non-Judicial stamp of `10/- (Ten) within date specified in the letter of acceptance.
- 7. In case of the Tenderer whose tender has been accepted and who has executed the agreement the earnest money deposited will automatically be converted to Security deposit. An amount of 8.0% of the value of work executed will be deducted from each progressive bill. This amount along with the 2.0% earnest money deposited earlier will constitute the security deposit. Such security deposit will be refundable after six months on successful completion of work. In case of failure the part of the selected tenderer to complete the work within the stipulated time, security money deposited will be forfeited
- 8. If the selected tenderer fails to execute the agreement within the date mentioned in the letter of acceptance, he shall be through to book for disciplinary action and his earnest money will be forfeited
