1. Vidyasagar University will upload the result of PG Course (combined 1<sup>st</sup> & 2<sup>nd</sup> Semesters) with percentage of marks (average SGPAx10) in the SVMCM Scholarship Portal – as reported.
2. The students have to login in the SVMCM Scholarship Portal and apply for the scholarship. Students will not be able to change the percentage of marks shown in the portal. Students have to enter total marks obtained in the course and full marks of the course in the portal. If there is any mismatch between the percentage of marks as uploaded by the university and percentage of marks obtained from exact calculation from the data entered by the student, the Principal will put remarks during forwarding the application Form taking approval from higher authorities.
3. The students in person have to submit the hardcopy along with all documents to the scholarship section on working days.
4. The students (appeared in 1<sup>st</sup> Semester examination and took admission in PG semester-II) are advised to come to the college on 18.03.2026 for physical verification of photo, bank account, marks and other documents.

It is also notified that no student can take admission during 23.03.2026-31.03.2026 for account settlement works at the end of the Financial Year 2025-2026.
